Plan of Organization Update- Marshall Conrad reviewed several things that were included in the new plan and there were a few questions from the members. It will be presented by committee at the state convention in Greensboro on June 7th.

Resolutions-the three resolutions that were sent back to committee at convention, as well as one new resolution, were opened for discussion.

- *Condemnation of State Senator Phil Berger*, presented by Jim Womack. Much discussion and debate took place regarding this topic, and then the call to question was made, and there was a vote. Votes in favor of the resolution were 18; votes opposed to the resolution were 7; votes to abstain were 5. Resolution was approved.

- *Condemnation of Senator Tillis*; presented by Jim Womack. There was some discussion and all questions were answered. The vice chair called for a voice vote and the resolution passed with a majority vote.

- *Cash is Freedom*; presented by Jean Casanave. Reviewed the change of language from the presentation at convention. The vice chair called for a vote. Resolution passed unanimously.

- *Resolution to Dismiss Linda Devore as NCGOP Credentials Chair*, presented by Jim Womack. A motion was made to suspend the rules to accept this resolution, because of lack of proper notice to committee.
